

Subject: APAAR ID – Reg.

Dear parents/legal guardians,

Automated Permanent Academic Account Registry (APAAR), is a specialized identification system designed for all students in India. This initiative is a part of the 'One Nation, One Student ID' program launched by the Ministry of Education, Govt. of India, aligning with the new National Education Policy of 2020. APAAR ID helps in a seamless integration of skills and experience into a credit-based system.

This unique 12-digit code will help the students to digitally store, manage, and access all their academic credits, including Score card, marksheets, gradesheet, degrees, diplomas, certificates & co-curricular accomplishments. This ID functions as a permanent digital identity for the student in the education ecosystem.

APAAR ID is now Mandatory for students of classes IX-XII to register for CBSE Examinations.

The following details are mandatory required for APAAR ID creation in the school level:

1. UDISE+ Unique Student Identifier - **Permanent Education Number (PEN).**

- PEN is generated to all the students who were studying in this school in 2024-25.
- Newly admitted students will have to obtain and submit their PEN from their previous school (if attended any).

2. **Aadhaar of the student** - (Student records like Student Name, Date of Birth (DOB), Gender, in Aadhaar must match with the records in School/UDISE+.

- You may check the Aadhaar Number of the student under the 'information tab' on the school mobile app '**St Pauls School Mala Road Kota**' which is available on Google Play & App Store. (Kindly send a copy of the Aadhaar Card of the student if the information is not available/incorrect).

- **Mandatory Biometric Update need to be completed on attaining the age of 5 & 15.**

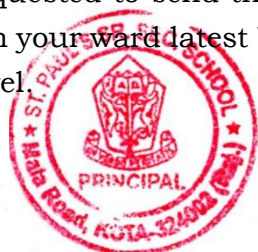
3. **Physical consent of the parent/legal guardian** – Physical consent of any one of the parents/legal guardians along with a copy of the following Identity Proof; (**any one**)

- Aadhaar (Not masked Aadhaar)
- PAN
- EPIC/Voter ID
- Driving License
- Passport

Once APAAR ID is generated, it will be pushed into student's DigiLocker Account. Student can find virtual APAAR ID Card in Issued document section of DigiLocker.

Therefore, you are requested to send the consent form attached herewith & the document(s) (if required) along with your ward latest by 25th August 2025 to generate the APAAR ID of your ward in the school level.

I understand that UIDAI will share my e-KYC details, or response of "Yes" with Ministry of Education upon successful authentication.

I understand that the information shared by me shall be kept Confidential and shall not be divulged to any third party except as may be required by law.

I understand that I can withdraw my consent for all or any of the purposes at any time by and on withdrawal of my consent, the processing of my shared information will stop, however, any personal data already been processed shall remain unaffected on such withdrawal of consent.
